Shared Outcomes Fund - Changing Futures — A £46 million scheme to provide more effective and coordinated support for some of the most vulnerable people in our communities, has been launched this month. The government is inviting local organisations to form partnerships and bid for a share of the funding to better support those who experience multiple disadvantages including homelessness, substance misuse, mental health issues, domestic abuse, and contact with the criminal justice system. The [prospectus](#) invites expressions of interest from organisations such as councils, health bodies, police, probation services, voluntary and community sector organisations to form local partnerships. National Policing Vulnerability Knowledge and Practice Programme (VKPP) - The VKPP have asked for some information on two areas of emerging/growing concern:

1. Increase in 'stowaways' being found in ports; and
2. Young people being found in hotels

They use knowledge from forces, NPCC leads, NCA, College of Policing and a range of external partners to understand practice to address vulnerability and serious violence and are aiming to get a better picture of the what conversations and work is occurring around these issues. Modern Slavery Act Statutory Guidance Update — On 30 November the Home Office published an update to the Modern Slavery Statutory guidance. This update included some revised text about attendees of the Statutory Guidance Reference Group, additional information on how cases are shared with Multi-Agency Assurance Panels and content which is intended to provide greater clarity in regard to the extent of the guidance in Scotland and Northern Ireland, having worked with the relevant devolved administrations to achieve this. As a result, the title of the guidance has been changed to Modern Slavery: statutory guidance for England and Wales (under s49 of the Modern Slavery Act 2015) and non-statutory guidance for Scotland and Northern Ireland. The updated guidance is available [here](#).

Home Office First Responder Training — The Home Office have an online modern slavery training module for all First Responders. The aim of the training is to provide all First Responders with a consistent level of knowledge to enable them to effectively identify and refer, where appropriate, potential victims of modern slavery to the National Referral Mechanism (NRM). Although this training is aimed at First Responders, it contains useful information for all partners.
