

# Coronavirus briefing: safeguarding guidance for schools

**This briefing summarises the latest guidance for UK schools on safeguarding and child protection during the coronavirus (COVID-19) pandemic.**

**25 January 2021**

## Introduction

As the coronavirus pandemic has progressed and restrictions have changed, schools have regularly had to adapt the way they teach and support children and young people. We have pulled together key guidance from all four UK nations to help professionals understand their safeguarding and child protection responsibilities at this time.

This briefing will be updated regularly.

We have also published a briefing for early years providers, pulling together key guidance on the coronavirus pandemic.

## England

In England, the Department for Education (DfE) has stated that only vulnerable children and the children of critical workers should be attending school for face-to-face learning during the national lockdown that began on 05 January 2021. This applies to all schools and further education settings. All other children from Reception upwards should learn remotely until February half term 2021 (DfE, 2021a; 2021b).

Alternative provision, special schools and special post-16 settings may continue to offer face-to-face provision to all children, where appropriate (DfE, 2021a; 2021b; 2021c).

The DfE has published a range of guidance to help schools during the pandemic.

### Safeguarding and child protection

Schools should continue to follow the statutory safeguarding and child protection guidance, **Keeping children safe in education** (DfE, 2021d).

The key guidance for schools and colleges provides more detail on safeguarding and child protection during the pandemic.

## Northern Ireland

In Northern Ireland, only vulnerable children and children of key workers should currently have access to supervised learning in school. Mainstream education settings should provide remote learning for all other children and young people until the half term break in February (Department of Education, 2021a).

Special schools should remain open to all children and young people. Education other than at school (EOTAS) provision should continue operating as normal with remote learning for those who do not attend (Department of Education, 2021a).

## Scotland

In Scotland, only children of key workers and vulnerable children should attend school in person. All other children and young people should receive remote learning until the middle of February (Scottish Government, 2021a).

Schools should continue to follow the [National guidance for child protection in Scotland](#) (Scottish Government, 2014).

## Wales

In Wales, only children of critical workers and vulnerable children should currently attend school or college in person. All other children and young people should receive remote learning. These measures will be reviewed on 29 January 2021 and if rates of community transmission have not reduced significantly by then, schools and colleges should continue online provision until February half term (Welsh Government, 2021a; 2021b).

Special schools and pupil referral units should remain open to support vulnerable children and young people where possible (Welsh Government, 2021a).
